The V5C vehicle registration certificate is one of the main documents you will want from the car owner if you're buying a second hand car. Without the V5C, more commonly known as the log book, you may not be able to tax the vehicle, so you won't be able to drive it. A lost log book can easily be replaced.

How to replace lost car documents - Admiral.com Title deeds vary by design but always include vehicle-specific information at the front of the document (such as: year, make, model, VIN, color, etc.) and several boxes for transaction information at the back where information about change of ownership is recorded (such as sale date, odometer reading, seller and buyer names and signatures, etc.). In-state vehicle sales are recorded at the back of the title as long as there are unused reassignment boxes.
